# SPECIAL EDUCATION

#### INFANTS AND TODDLERS

The only program of its kind in Broward County to serve children under 3 during the most critical stages in brain development. We provide the necessary services to help them reach their utmost potential, by providing therapeutic, medical and developmentally appropriate readiness and play skills.

#### EARLY INTERVENTION PRESCHOOL

Children aged 3-5 with an active IEP referred by the School Board of Broward County. It includes necessary therapies during classroom hours and offers intensive and specialized classrooms with a low teacher-to-student ratio.

#### ELEMENTARY PRIVATE SCHOOL

Our Private School provides educational and therapeutic services for children with special educational needs grades K-5. To ensure that ASC follows best practices, our team and families collaborate to assist students of all abilities and developmental levels achieve educational, communication, independent functioning, and social skill goals. We allocate time, resources, strategies, interventions, and appropriate support by using our in-house trained staff to provide exceptional guidance, lesson planning, and teamwork.

#### AFTER SCHOOL & SUMMER CAMP

Dynamic enrichment programs funded by the Children's Services Council of Broward County, offers children with an active IEP (aged 3-10) safe, positive programming after school and during school breaks featuring arts and crafts, STEM, social-emotional development, and cultural arts.

# RESIDENTIAL CAPE

Residential placement is a wonderful, inclusive and caring solution for families who can no longer meet the support needs of a loved one with a developmental disability. We offer 2 types of residential services.

#### INTERMEDIATE CAPE FACILITY (ICF)

We have 2 Intermediate Care Facilities for Individuals with Intellectual Disabilities (ICF/IID) located in Ft. Lauderdale and Pembroke Pines. Each ICF/IID has 3 family-style homes.

#### GROUP HOMES

For more independent individuals, we offer group home options for those 18 and above. Each group home is a small family oriented setting with 6 individuals per home. They are staffed 24 hours a day with a focus on independent living skills.

## HOW IT ALL BEGAN...

Our story speaks beautifully to advancement of mission, sustained purpose and profound impact. It originates in 1951, when pediatric nurse Ann Storck retired to South Florida to open her heart and home to a handful of disregarded children with developmental disabilities. Four years later, she opened the Pediatric Care Center to serve 55 children. The Pediatric Care Center evolved into Ann Storck Center in 1981.

Today the Center accommodates 96 permanent residents and serves more than 300 clients daily through an array of critical care, learning and ability focused programs across two distinct campuses in Fort Lauderdale and Pembroke Pines. We are the oldest non-profit in Broward County to serve this vulnerable population.

Ann Storck Center boasts nearly 300 dedicated employees, a majority of whom have been with the organization 20 plus years. We hold this up as the greatest testament to our lasting impact on the community and the lives of those we serve.
